Pursuant to art. 13 of Legislative Decree 196/03 and following the entry into force of EU Regulation n. 679/2016, in accordance with the provisions of art. 13 of the aforementioned European Regulation, we wish to inform you of the following:

**Purpose of the data processing:**

Your personal data, freely communicated and acquired by us as a result of the activity carried out by **Ad Arte s.r.l.** will be processed in a lawful and correct manner for the following purposes: administrative, accounting, and commercial, to follow up requests and to document your participation in the event as well as to fulfil legal obligations. The data may be disclosed and provided to different, but well-identified subjects who, in various capacities, contribute to or participate in the event, as well as to the competent Authorities according to the provisions of law and, possibly, AGENAS for CME purposes. With your specific consent, your data will be used to send a periodic newsletter updating you on events of interest organized by Ad Arte s.r.l. Your data will not include information of a so-called "sensitive" nature, but may include "judicial" data, in the event of a dispute.

**Method of data processing:** Your data will be processed, in compliance with the necessary security and privacy, through the following methods: collection of data from the data subject directly or through electronic means such as e-mail. The data will be collected and recorded for specific, clearly stated and legitimate purposes and undergo further processing operations compatible with these purposes, the processing will be carried out with or without the aid of electronic and automated instruments, and the data will be stored in a form that allows identification of the data subject for a period that does not exceed the time indicated below.

**Legal basis of the data processing:** The legal context of the processing of your personal data is based on an agreement signed between the parties or an awarded contract (counter-signed order).

**Legitimate interests pursued by the data controller:** Pursuant to art. 6 the legality of the processing is based on the express consent of the data subject.

**Mandatory or optional nature of providing data and consequences of a possible refusal:** You must provide your data in order for the requested products to be supplied; if you refuse to provide the necessary data, it will be impossible for us to be your supplier.

**Disclosure of data to third parties:** Following inspections or checks, your data may be disclosed (if requested) to all the inspection bodies responsible for checks and controls concerning compliance with legal obligations. Your data may also be disclosed to companies/professional firms that provide assistance, advice of accounting, administrative, fiscal, legal, tax or financial nature, for bookkeeping purposes.

**Storage period:** Your personal data will be stored for 10 (ten) years from the termination of the supplier-customer relationship.

**Existence of an automated decision-making process:** There is no automated decision-making process; data are not subject to profiling.

**Intention of the personal data controller:** The data controller will not transfer your personal data to a third country or international organization.

**Data controller and processor:** The data controller is **Ad Arte S.r.l.**, with its registered office in via Barberia n. 14 in Bologna (BO), Italy. Dr. The data subject may exercise his or her rights at any time, as laid down by art. 7, reported in full.

**Art. 7 Legislative Decree 196/2003 and art. 15 EU Regulation 679/2016 – Right to access personal data and other rights** –The data subject shall have the right to obtain confirmation of the existence or not of personal data concerning him or her, even if not yet registered, and receive this communication in an understandable form. The data subject has the right to obtain information on: the origin of the personal data; the purposes and methods of the data processing; the logic applied in the case of processing carried out with the aid of electronic instruments; the details identifying the data controller, the data processor and the designated representative pursuant to art. 5 paragraph 2; and the recipients or categories of recipients to whom the personal data may be disclosed or who may be informed of them as appointed representatives in the State's territory, managers or agents. The data subject has the right to obtain: updating, rectification or, when relevant, integration of data; erasure, transformation into anonymous form or blocking of data processed unlawfully, including data that do not need to be stored for the purposes for which the data were collected or subsequently processed; and a statement that the operations referred to in letters a) and b), and their contents, have been brought to the attention of those to whom the data have been disclosed or disseminated, except in the case in which it is impossible to do this or it would require the use of means manifestly disproportionate to the protected right. The data subject has the right to object in whole or in part: for legitimate reasons to the processing of personal data concerning him/her, even though they are relevant to the purpose of the data collection; to the processing of his/her personal data for the purpose of sending advertising or direct sales material, market research or commercial communications. In particular, the data subject may ask the data controller at any time for access to his/her personal data and rectification, erasure or restriction of processing of the data or oppose their processing, in addition to having the right to data portability. The data subject has the right to withdraw consent at any time without prejudice to the lawfulness of the processing based on the consent given prior to the revocation of consent and has the right to lodge a complaint with a supervisory authority.
